INSTRUCTIONS

Section A: Note 1 – The name of manufacturer, model, and serial number must be written exactly as they appear on the aircraft identification plate. Attach a clear photograph of the Aircraft Identification Plate that identifies the name of manufacturer, the model, and the serial number.

Note 2 – If you have reserved a registration mark, enter it here. Otherwise, an available registration mark will be automatically assigned upon registration, for no additional charge.

Note 3 – Attach a completed copy of the Statement of Conformity or, if the aeroplane is used, the Fit For Flight form.

Note 4 – Transport Canada Civil Aviation (TCCA) cannot register an imported aircraft before receiving notification from the foreign civil aviation authority that the aircraft is not registered in the foreign state. Notification to be sent to AirRegFax@tc.gc.ca.

Section B: Note 5 – Attach a copy of the bill of sale, lease, last will and testament, statutory declaration (affidavit), or other legal document that establishes the applicant for registration as the person receiving custody and control of the aircraft. **Do not send original documents.**

Section C: Note 6 – Attach copies of documents proving age and citizenship or permanent resident status. If there are more than two owners applying for registration, an additional sheet of paper should be attached to the application which lists those applicants' names, addresses, telephone numbers and signatures.

Note 7 – TCCA will send the Certificate of Registration, Airworthiness Directives, Safety Alerts, etc. only to the first person on this list.

Section E: Note 8 – If an agent is acting on behalf of an individual applicant, attach documentation that establishes the signing authority of the agent.

Section F: Note 9 – Attach a copy of the entity's certificate of incorporation or equivalent document.

Section G: Note 10 – Attach evidence that establishes the signing authority of the officer.

Registered owners are responsible for notifying Transport Canada within 7 days of any change to the registration information. There is no charge for a change of address.

PRIVACY NOTICE

Transport Canada (TC) is committed to protecting the privacy rights of individuals and safeguarding the personal information under its control. "Personal information" is defined as any information, in any form, about an identifiable individual; refer to section 3 of the Privacy Act for further details regarding personal information. Personal information collected by TC is protected from disclosure to unauthorized persons and/or agencies subject to the provisions of the Privacy Act. The collection and disclosure of personal information is done under the authority of *Aeronautics Act*, pursuant to subsections 202.02, 202.16, 202.35, 202.51, 202.52, 202.57 and 203.03 of the Canadian Aviation Regulations (CARs). Information will also be disclosed to foreign aviation authorities to fulfill the obligation under Article 21 of the Chicago Convention underlying the International Civil Aviation Organization (ICAO). Information in the Canadian Civil Aircraft Register, such as the names and addresses of registered aircraft owners, is accessible by the general public. Personal information is used by and linked to other Civil Aviation databases such as the National Aeronautical Product Approval System (NAPA), the Continuing Airworthiness Web Information System (CAWIS), the National Aviation Company Information System (NACIS), the Enforcement Management System (EMS), and the Civil Aviation Daily Occurrence Reporting System (CADORS), in order to populate, within each respective database, information relating to the registration and licensing of aircraft. Personal information will be protected under the provisions of the Privacy Act and is described in TC's Personal Information Bank number TC PPU 010, which is detailed in TC Info Source Chapter at www.tc.gc.ca. Individuals have the right to file a complaint with the Privacy Commissioner of Canada regarding the institution's handling of their personal information.
